## 9. ACE WATER PIPELINE

Mayor Sosnowski informed council about a meeting held with ACE and Alberta Environment earlier in the day. The meeting was called in response to notification to County of Vermilion River from Alberta Transportation that funding for contract 12 had been approved to a maximum of 90% of eligible project costs up to a maximum of \$3,434,551.00. A letter outlining concerns has been address to Alberta Transportation Minister Wayne Drysdale.

Win Tun from Alberta environment was in Myrnam on Tuesday as well to complete additional testing on Myrnam Raw water to establish a short-term solution to meeting the 4-Log virus standards. This will involve substantial increase in Chlorine added to Myrnam's drinking water and represents a Band-Aid approach until Myrnam is connected to the regional water pipeline.

Mr. Tun also explained the 4-Log Virus scenario facing many communities scheduled to be connected to the ACE pipeline. He reiterated that both Alberta Environment and Alberta Transportation indicate connection to the ACE Pipeline is the only viable alternative for the Village under the circumstances. ACE had requested the Village reconsider withdrawal from the project in October 2013. ACE has requested the Village provide additional guidance following the public meeting with Myrnam residents.
